# **Description:**

Bank is one of the most active lenders in the UK having lent over £2bn with c.20,000 savings customers. Its loans have directly helped with the creation of 8,500 new homes and 8,000 new jobs in the UK, as well as adding several billion pounds to the economy.

The Loans that Bank provides to its customers are often secured by one or more items of collateral. In the UK, these items of collateral must be registered at Companies House. Registration of collateral is done by external solicitors on behalf of Bank. This project aims to ensure that collateral is registered and deregistered in time at Companies House, and that a regular report of any exceptions is distributed to the business.

Bank keeps track of the collateral it uses in Salesforce, as part of the nCino managed package. Companies House offers access to collateral registration through a RESTful API. Because the registration of collateral at Companies House is done by Bank's solicitors, there is no direct identifier that can link the two systems at the time of registration.
