***Security Reference Master for Personal Advisor*** - A multi-year, multi-million dollar initiative to provide a sell side security reference master platform for retail clients enrolled for investment advice services. The scope of the project includes source, store, steward and distribute security reference master data from Vanguard's internal applications for Vanguard's investment products, industry standard investment security data from Thomson Reuters, JJ Kenny, FACTSET, SUNGARD and Bloomberg and provide the data as a GOLD copy (best possible combination of from all these data providers as determined by the business team) for use.

This project initiative was considered to be a green field from a technical architecture perspective as it is built from the ground up. As a result, the application was built using Java as the primary application programming language, Native SQL stored procedures and embedded SQL to access DB2 databases for the new tables.

**Corporate Cash flow reporting** – Rewrite of a legacy and manual intensive cash flow reporting of funds to use Java/DB2 to provide end of day and end of month level cash flow reports to senior management and portfolio managers to make informed decisions.

**Data Governance - Enterprise Data Lineage and Traceability** - A multi-year, multi-million dollar initiative to follow best practices in managing the data within internal systems. This initiative includes identifying the best in class data lineage providers and evaluating their product offerings to best meet the company's goals.

**Next Generation Fund Holdings Roll Up** - The funds' holding roll-ups for investment sectors were recalculated to align with their new benchmarks. The new benchmarks from FTSE (Financial Times Stock Exchange) and Russell investments replaced MSCI (Morgan Stanley Capital International) provided benchmarks.

**ProjectOne-** Transaction History Re-Architecture - The transaction history application was re-written to accommodate the handling of mutual fund, brokerage, annuity, 529 educational accounts, 401k and employer retirement plan accounts into one work-flow.
