These products exhibit complex exposure and rating characteristics, and require a vast array of documentation (i.e., declaration pages, endorsements,etc.).

The platform is largely a custom system utilizing the Web2.0 technologies. It is built on top of a product configuration engine that has been licensed from Camilion (now SAP). It uses a service-oriented architecture to allow for both internal communications within CCUW, but also with the nine separate AIG applications with which it operates (i.e., iSuite, CASL, eStart, PLS, SharePoint, EPN, Publishing Services, NGBS, etc.). The platform has a rich user interface and is certified for IE 11 and Firefox., and currently supports several hundred users at numerous locations in the US, Canada, and Manila Shared Services.
